THIS ALSO INCLUDES, WITHOUT LIMITATION, ANY LIABILITY (INCLUDING CONSEQUENTIAL, INDIRECT, SPECIAL OR INCIDENTAL DAMAGES) ARISING FROM INJURY OR DAMAGE THAT I SUFFER OR CAUSE DURING MY PARTICIPATION IN THE AZCCD, WHETHER SUCH INJURY OR DAMAGE IS FORESEEN OR UNFORESEEN OR WHETHER RESULTING FROM NEGLIGENCE OR OTHERWISE. I AGREE THAT THIS WAIVER AND RELEASE IS INTENDED TO BE AS BROAD AND INCLUSIVE AS PERMITTED BY APPLICABLE LAW. IF ANY PROVISION OF THIS WAIVER AND RELEASE SHALL BE INEFFECTIVE OR INVALID, SUCH PROVISION SHALL BE INEFFECTIVE OR INVALID ONLY TO THE EXTENT OF SUCH PROHIBITION OR THE REMAINING PROVISIONS OF THIS WAIVER AND RELEASE, WHICH SHALL REMAIN IN FULL FORCE AND EFFECT.
